ORDINANCE #10/18

**AN ORDINANCE AMENDING CHAPTER 69 OF THE CODE OF THE TOWN OF
WEST NEW YORK ENTITLED “MUNICIPAL ADMINISTRATOR”**

WHEREAS, Chapter 69 of the Code of the Town of West New York (“Town”) creates the office of Municipal Administrator; and

WHEREAS, also pursuant to Chapter 69, the office of Municipal Administrator falls under the supervision and direction of the Department that is overseen by the Mayor; and

WHEREAS, the Board of Commissioners now seek to amend Chapter 69 with respect to the Department that supervises and directs the office of the Municipal Administrator; and

NOW, THEREFORE, BE IT ORDAINED by the Mayor and Board of Commissioners of the Town of West New York, that Chapter 69 entitled “Municipal Administrator” shall be amended as follows:

Section One

Chapter 69-100B shall be deleted and replaced as follows:

The office of the Municipal Administrator shall fall under the supervision and direction of the Commissioner of Revenue and Finance.

Section Two

Severability. The provisions of this Ordinance are declared to be severable and if any section, subsection, sentence, clause or phrase thereof for any reason be held to be invalid or unconstitutional, such decision shall not affect the validity of the remaining sections, subsections, sentences, clauses and phrases of this Ordinance, but shall remaining in effect; it being the legislative intent that this Ordinance shall stand notwithstanding the invalidity of any part.

Section Three

Repealer. All ordinances or portions thereof in conflict or inconsistent with this Ordinance are hereby repealed, but only however, or the extent of such conflict or inconsistency, it being legislative intent that all ordinances or portions of ordinances now existing or in effect shall remain in effect unless the they are in conflict or inconsistent with any provision of this Ordinance.

Section Four

When Effective. This ordinance shall take effect upon passage and publication as required by law.

SUMMARY OF ORDINANCE

This Ordinance amends Chapter 69-100B by changing the Department that supervises and directs the office of the Municipal Administrator from that which is overseen by the Mayor to the Department of Revenue and Finance.
