ORDINANCE #11/15

AN ORDINANCE AMENDING CHAPTER 56-9 “ASSIGNMENT OF DEPARTMENT”

WHEREAS, the Town of West New York has assigned all powers and duties relating to its Law Department to the Department of Revenue and Finance; and

WHEREAS, the Town of West New York has, since such assignment, determined that in the interest of efficiency and a more effective administration of government, it is more appropriate that all the powers and duties of the Legal Department fall under the supervision and direction of the Department that is overseen by the Mayor of the Town of West New York;

NOW, THEREFORE, BE IT ORDAINED by the Mayor and Board of Commissioners that:

SECTION ONE

The entirety of Chapter 56-9 is deleted and replaced with the following:

All powers and duties relating to the Law Department are hereby assigned to and distributed in the Department that is overseen by the Mayor of the Town of West New York.

SECTION TWO

Severability. The provisions of this Ordinance are declared to be severable and if any section, subsection, sentence, clause or phrase thereof for any reason be held to be invalid or unconstitutional, such decision shall not affect the validity of the remaining sections, subsections, sentences, clauses and phrases of this Ordinance, but shall remaining in effect; it being the legislative intent that this Ordinance shall stand notwithstanding the invalidity of any part.

SECTION THREE

Repealer. All Ordinances or parts thereof in conflict or inconsistent with this Ordinance are hereby repealed, but only however, to the extent of such conflict or inconsistency, it being the legislative intent that all Ordinances or part of ordinances now existing or in effect unless the same being conflict or inconsistent with any provision of this Ordinance shall remain in effect.

SECTION FOUR

This Ordinance shall take effect upon passage and publication as required by law.

SUMMARY OF ORDINANCE

This Ordinance changes the designation of the Law Department from the Department of Revenue and Finance to the Department that is overseen by the Mayor.
