**ORDINANCE #21/24**

**RE: AUTHORIZING THE INSTALLATION OF “STOP” SIGNS AT THE  
FOLLOWING INTERSECTIONS: BROADWAY AVENUE AT 50<sup>TH</sup>  
STREET AND BROADWAY AVENUE AT 51<sup>ST</sup> STREET IN THE TOWN  
OF WEST NEW YORK**

**WHEREAS**, pursuant to N.J.S.A. §39:4-197, the Town of West New York (the “Town”) may authorize the installation of “stop” signs along roadways within its jurisdiction, subject to approval by the Commissioner of the Department of Transportation under N.J.S.A. §§ 39:4-202 and 39:4-8. and

**WHEREAS**, the Mayor and the Board of Commissioners of the Town of West New York seek to authorize the Town to erect “stop” signs on Broadway Avenue at 50<sup>th</sup> Street and 51<sup>st</sup> Street in the Town of West New York; and

**WHEREAS**, the Town shall erect the proper regulatory signs at the intersections identified herein and a certified copy of this Ordinance shall be provided to the New Jersey Commissioner of Transportation for approval, in accordance with N.J.S.A. § 39:4-197; and

**WHEREAS**, the Town shall be responsible for the enforcement of all applicable traffic regulations governing the “stop” sign locations as set forth herein.

**NOW THEREFORE, BE IT ORDAINED** by the Mayor and the Board of Commissioners of the Town of West New York, County of Hudson, State of New Jersey do hereby authorize as follows:

**SECTION ONE**

“Stop” Signs shall be erected at the following locations within the Town of West New York:

1. Broadway Avenue at 50<sup>th</sup> Street
2. Broadway Avenue at 51<sup>st</sup> Street

**SECTION TWO**

Severability. If any article, section, sub-section, sentence, clause, or phrase of this ordinance is for any reason deemed to be unconstitutional or invalid by any court of competent jurisdiction, such decision shall not affect the remaining portions of this ordinance.

### **SECTION THREE**

All ordinances or parts of ordinances and the Town of West New York regulations inconsistent with this ordinance are hereby repealed to the extent of such inconsistency.

### **SECTION FOUR**

This ordinance shall take effect immediately upon passage and publication as required by law.

### **SECTION FIVE**

**Codification.** The Town Clerk shall have this Ordinance incorporated in the official copies of the Code of the Town of West New York. The Town Clerk and the Town Attorney be and are hereby authorized and directed to correct any typographical error in this Ordinance and change any heading, chapter numbers, article numbers and section numbers in the event that the codification of this Ordinance reveals that there is a conflict between those headings and numbers and existing provisions of the Code of the Town of West New York, or as they may otherwise deem appropriate, even if the headings, chapter numbers, article numbers and section numbers thus modified are otherwise provided for in this Ordinance.
